I read the proposed budget changes in discuss...The proposed PD overtime budget was \$475,000 not \$400,000....Now the tentative overtime budget for the PD for 2020-2021 is \$360,000. Thats \$30,000 a month in overtime...The village is 2.1 square miles and according to Clarke, Suffern is one of the safest villages in the NYS. So that would elude to its not a high crime area which is great. But the question is, why do we need a budget of \$360,000...Thats ridiculous...Their budget should be frozen at \$300,000 which I think is still ridiculous...Maybe mismanagement is to blame on that.

2nd, there is no justification for the Village Clerk to go from \$80,850 to 84,893..Other Department heads are getting no increase. Thats Ed again taking care of his own!!

3rd, I think you seriously need to reevaluate laying off the entire recreation department. I don't know how you made the decision to close the village pools when the Governor of this State didn't even have a discussion about that phase nor did the CDC. Your decision is too premature...It would roughly cost \$35.00 a year per household to maintain the two positions and programs that includes most importantly our Senior citizens. They are the pillar of the village. Programs may change depending on how the pandemic lasts but the village will at last have some things or give us the opportunity to figure out how to keep some kind of normalcy in our village. Remember there might not be any camps either, these kids in our village will need something to do if it is not on a daily basis. Eliminate the \$60,000 additional for the PD overtime budget and save the recreation department.

4th, no increase in the overtime budget for the street department?? This department needs and deserves the overtime increase. The employees from the street department are working twice as hard now with trash removal etc with everyone being home.

Once again, I find myself shocked by the actions of the current Board of Trustees and question their ability to provide proper governance to the residents of the Village of Suffern.

While I believe everyone can agree that the Village has a Recreation Department that provides a valuable service to the community and its staff is exemplary, I understand why you may look to eliminate funding due to its "non-essential" nature. What is questionable is why you would decide to keep the highest paid employee whose primary function is to direct and/or administrate employees and events. By defunding the positions, you have no opportunity during the budget year to bring back those services to community should the opportunity arise. Please explain the reasoning behind your actions and why you feel it's important to keep a boss when you've eliminated all the workers and the programs?

We find ourselves in a situation that is unprecedented. There are many unknowns and many hard choices to be made in the near future. There is also hope that the worst case scenarios will not happen to us all. I think that there are many other ways to tighten the budget that can provide relief to the taxpayers. For example:

- 1. Eliminate the budgeted overtime for Justice @ \$6000, Village Clerk's Office @ \$7,500, Safety Inspections @ \$500, Treasurer's Office @ \$2,500.
- 2. Rather than having another Police Records Person, re-allocate the services of the Police Youth Officer to provide coverage for the recently added P/T additional Records Person @ \$17,784 AND/OR provide the revenue generating services of the parking enforcement aide at \$14,820
- 3. The overtime budgets for Waste, Water, Sewer, and Police total \$588,000. Additional cuts should be made from ALL departments in order to lessen the burden on the taxpayers. The justification and requests for overtime should be an ongoing evaluation throughout the year and overtime needs be justified at every Board meeting.
- 4. DARE expenditures should be reduced for this fiscal budget year as those activities will be curtailed for the foreseeable future.
- 5. Lastly, the current Board of Trustees has not worked in the best interests of their constituents. If you are in favor of closing departments, laying off personnel, and asking taxpayers to foot the bill for increased taxes, you need to take a substantial pay cut as well.

There is an argument to be made for keeping the Recreation personnel employed right now. There is opportunity for them to re-invent their classes and services to the community while keeping social distance. Right now, every single person is starved of human contact which has an emotional toll. The opportunity to be part of a community will be eliminated by your proposals. Right now, we should be looking to find ways we can help engage residents in our community and provide ways to relieve the stress of this worldwide pandemic and look for opportunity to revitalize our businesses.

Ask something from everyone. Every department shares some of the pain in order to keep all of our departments functioning for the benefit of the community they serve.
