## Village of Suffern Department of Public Works Snow Plow Operators Permit

Local Law No. 3 of the Year 2014, Section 235-6 Section D

- D. (1) No person, firm or corporation shall plow snow, ice sleet or similar matter or cause or allow the same to be plowed or placed by the use of any vehicle within the Village of Suffern unless a permit therefor, as hereinafter prescribed, issued by the Village Clerk, is in full forced and effect and such permit is prominently displayed by affixing to the vehicle so as to be readily visible from the exterior thereof.
- (2) Application for such permit shall be made to the Village Clerk by the owner of the vehicle, in writing, upon forms to be furnished by the Village Clerk, which forms shall contain the owner's name and address, the operator's name and address, the vehicle identification number, the New York State license number attached thereto and such additional information as the Village Clerk shall require and shall be accompanied by the permit fee set forth in the Schedule of Fees. The Village Clerk may require such documents and information as may be reasonably necessary to verify the facts stated in such application.
- (3) Such permit shall be for the period of October 1 to September 30 of each year and may be revoked by the Board of Trustees upon notice to the permittee and an opportunity to be heard and may also be suspended by the Mayor upon good cause, including violation of this section, until a determination on revocation of the permit is made.
- (4) This section may be enforced by the Village of Suffern Police Department, and/or the Building Inspector, or Code Enforcement Officers and their deputies and they are authorizes to issue appearance tickets pursuant to Article 150 of the Criminal Procedure Law of the State of New York for the violation of any section.

Local Law No. 3 of the Year 1990, Section 136-5 Section B

B. It is prohibited to deposit snow or ice on any sidewalk, street, right-of-way or storm drain or to obstruct any drainage course. It is further prohibited to pile or plow snow to a height of three feet or more within 10 feet from any corner or intersection of any road or highway. The provisions of this subsection shall not apply to employees of the Village of Suffern in the performance of their duty.
