Mayor Curley called the meeting to order at 7.04 P.M. and led everyone in the Pledge of Allegiance and a moment of silence for all of our veterans and all those who lost their lives fighting for the freedoms we have today.

# MOTION TO APPROVE MINUTES FROM JANUARY 9, 2023, VILLAGE OF SUFFERN BOARD MEETING.

A motion to approve the Board minutes was made by Trustee Meegan-Corrigan and seconded by Trustee Alpert, with all in favor.

#### PRESENTATION OF AWARD

Mayor Curley presented an award to Michael Ludwig, Eagle Scout for the five benches he erected and for beautifying the area of Brooklands Park.

### FEES FOR ILLEGAL CONSTRUCTION

Mayor Curley explained that the Village Board wants to establish fees for residents who start doing construction on their homes without getting the necessary permits. These fees would be in addition to requiring the property owner to get the correct permits for construction. When work is done illegally, it is unfair to those who comply with the law, requires more work for the Village to inspect, and endangers the health and safety of our community.

# MOTION TO OPEN THE PUBLIC HEARING AT 7:05 P.M., FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT.

A motion to approve the foregoing was made by Trustee Meegan-Corrigan and seconded by Trustee Alpert, with all in favor.

Mr. Fred Rella explained the process of the Community Development Block Grant ("CDBG"). CDBG is an annual grant which is funded by federal funds and has been funneled to the County of Rockland. The Village of Suffern has to apply to the County of Rockland Office of Community Development with a particular project. The project has to be located in a low to moderate income area of the Village. The income areas are based on the 2020 US Census data. The Village of Suffern only has one low to moderate income area. That means that the average income for that area is 80% of the average income of the Village. The average income for the Village is \$89,000. In this area it is \$69,000 (51% of the people earn \$69K or less) per year.

The next step is to brainstorm to find a project to submit for the grant. There is a Citizen Advisory Committee. The Committee, a requirement of the grant, has recommended the repaving of Ed Fagen Drive, which goes from Ramapo Avenue, through the athletic fields to the DPW garage. The estimated cost to repave this road is \$150,000. The CDBG is looking for the Village to contribute \$10,000 or 7%.

### **RESOLUTION NO. 010 OF 2023**

# ACCEPTING THE VILLAGE OF SUFFERN CITIZEN ADVISORY COMMITTEE RECOMMENDATION FOR THE 2023 CDBG GRANT APPLICATION TO BE SUBMITTED FOR THE ED FAGAN DRIVE REPAVING PROJECT

**RESOLVED,** the Village Board of Trustees accepts the recommendation of the Village of Suffern Citizen Advisory Committee to seek Community Development Block Grant (CDBG) funding for the Repaving of Ed Fagan Drive and authorizes the Mayor or his authorized designee to sign and submit the 2023 CDBG application for the said project; and

**BE IT FURTHER RESOLVED,** that the CDBG application will state that the Ed Fagan Drive Repaving Project estimated cost is \$150,000. Of this total, \$140,000 will be contributed from the Community Development Block Grant and \$10,000 (approximately 7% of project estimated cost) will be contributed from the Village of Suffern. If a lesser amount of CDBG funds are awarded to the Village of Suffern, the Village contribution shall remain constant at no more than 7% of any such CDBG award unless the Village deems otherwise (i.e. a \$50,000 award will equate to a \$3,500 Village of Suffern contribution); and

**BE IT FURTHER RESOLVED,** additionally, that the Village of Suffern contribution can be the cost of a "project coordinator" and/or Village labor (soft) expenses for the development, implementation, and oversight of the Ed Fagan Drive Repaving Project.

# MOTION TO OPEN THE PUBLIC HEARING AT 7:15 P.M., TO AMEND CHAPTER 244 OF THE VILLAGE CODE REGARDING TAXATION.

A motion to approve the foregoing was made by Trustee Alpert and seconded by Trustee Meegan-Corrigan, with all in favor.

Mr. Giannettino, 2 Memorial Drive, asked which taxes were being proposed to amend.

Mayor Curley explained that there was an old taxation code in the Village. The history of the code had to do with the threat of Avon leaving Suffern and moving to Rella Blvd. Right now, if a business moves into the Village and undertakes capital improvements such as construction or reconstruction of facilities, that business could receive a significant real property tax exemption for up to ten years.

Mr. Giannettino asked if that was the main purpose of the change.

Mayor Curley said that there were two other reasons for the tax code changes.

Mr. Giannettino mentioned the PILOT with Avon. Mayor Curley answered that these tax code changes have nothing to do with Avon's PILOT. Mayor Curley repeated that it had to do with the law that is on the books and that needs to be changed. The real property tax burden should not be shifted from commercial entities and put on the homeowners.

The Mayor also mentioned that there were two other tax codes that need to be changed. The Board was adopting the tax code change for the New York State Senior Citizen exemption and the New York State Volunteer Firefighter exemption.

Mr. Giannettino commented that both of those were good causes and he stated that the Governor took a long time, but at least it was signed.

### Project Description, Background and Reasons Supporting the Negative Declaration:

The proposed action involves a legislative decision by the Village Board of Trustees to amend Chapter 244, Taxation, of the Code of the Village of Suffern. Said amendment would reduce the exemption set forth in Section 244-15 to zero percent (0%). In this manner, all commercial properties are taxed equally, whether existing or new construction. The Village Board has found that with the loss and/or significant downsizing of commercial properties in the Village, including the former Novartis property, Avon Products, and Tilcon Quarry among others, that it must ensure that it promotes fiscal policies that do not shift the burden of the cost of municipal services for new development onto existing development.

A short Environmental Assessment Form, Parts 1 and 2, have been prepared. The Part 2 has

evaluated the potential impacts of the action on the environment. As set forth in the Part 2, it is not anticipated that the proposed action will have any significant adverse impact on the environment.

### **RESOLUTION NO. 012 OF 2023**

**WHEREAS**, a public hearing was conducted on February 6, 2023, the public had an opportunity to comment thereon, Land the public hearing was closed.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of the Village of Suffern that Local Law No. 1, determining the Business Investment Exemption pursuant to Tax Law § 485-b to be 0% is hereby adopted and the Clerk is instructed to file the same with the Secretary of State.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of the Village of Suffern that Local Law No. 3 of 2023, providing a real property tax exemption for senior citizens pursuant to Real Property Tax Law § 467 is hereby adopted and the Clerk is instructed to file the same with the Secretary of State.

### ZONE CHANGE PETITION FROM EXTELL

Mr. Terry Rice explained that the Village Board received a zone change petition from Extell, which is seeking to obtain a zoning amendment to create multi-family housing on Washington Avenue. The proposal requires a lot of additional work before it is ready to be presented in a

public hearing. A proposal of this magnitude it is subject to State Environment Quality Review Act ("SEQRA") and will involve many local and state agencies. Since only one agency can be the lead agency under SEQRA, (for instance, the lead agency determines if an Environment Impact Statement is necessary, etc.), it is most advisable for the Village of Suffern Board of Trustees to be the lead agency.

In order for the Board to make itself lead agency, it simply adopts a notice of intent to be lead agency and sends a notice to all the other involved agencies that have permitting authority. The other agencies have 30 days in which to object. If you do not hear back from any of the other agencies, the Board will adopt another resolution confirming its status as lead agency.

The Village Planner and Mr. Rice both reviewed the zone change papers. The Planner wants some more particulars before the notice of intent to be lead agency is sent out. Mr. Rice suggested that the Board pass a resolution that it so desires to be lead agency on this project, but the notice of intent not be sent out until the planner is satisfied with respect to all of the documents required from the applicant.

### **RESOLUTION NO. 015 OF 2023**

DECLARING THE INTENT OF THE BOARD OF TRUSTEES TO BECOME LEAD AGENCY FOR THE SUFFERN WA LLC, MULTIFAMILY APARTMENT BUILDING APPLICATION INCLUDING THE TDD ZONE PETITION, SITE PLAN APPLICATION AND ALL OTHER PERMITS AND APPROVALS

WHEREAS, should the zoning amendment be approved, it will need various other land use approvals and approvals from various other agencies; and

**WHEREAS**, the Board of Trustees desires to act as lead agency for purposes of the State Environmental Quality Review Act; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Trustees of the Village of Suffern that, in accordance with the provisions of 6 NYCRR § 617.6, the Village of Suffern Board of Trustees declares its intent to act as Lead Agency for the purposes of SEQRA review of the aforementioned proposed action and shall assume SEQRA Lead Agency status if it does not receive notice of an objection from any Involved Agency within 30 calendar days of the date of this Notice of Intent.

#### FIRE DEPARTMENT

Mayor Curley thanked Fire Chief Jeremy Kaufer and all of the Fire Department personnel for taking care of the Village of Suffern residents no matter the weather conditions outside. The Mayor stated, "We all appreciate the service the Fire Department is doing."

Chief Kaufer thanked the Mayor and the Board.

### POLICE DEPARTMENT

Chief Loughlin presented the Police Department statistics for the month of January 2023. The Chief briefed the Board regarding an investigation that recently occurred within the Village of Suffern. A search warrant was executed at a local business Thursday, February 2, 2023, at the Zava Smoke Shop. The Police Department was receiving information that the Zava Smoke Shop, located at 28 Lafayette Avenue, was engaged in selling marijuana to both adults and juveniles.

The Suffern Detective Bureau initiated an investigation and confirmed this information. Suffern worked in conjunction with the Rockland County Intelligence Unit and the Rockland County Society for Prevention of Cruelty to Children. Several undercover operations were conducted, resulting in several sales of THC to minors.

A search warrant was executed by Suffern and other agencies on February 2, 2023, which resulted in the recovery of thousands of dollars' worth of THC products, hallucinogenic mushrooms, and other evidence being seized. Two suspects were arrested and charged with criminal sale of marijuana to both adults and juveniles. The investigation is ongoing, and it is expected that there will be additional charges.

The Chief thanked the other agencies and the detectives that worked on the investigation.

Mayor Curley thanked the Chief and said that he appreciated the good police work of getting out there and doing the job.

#### RECREATION

Ms. Cathy Mills thanked the Board for giving the award to Michael Ludwig. Ms. Mills recommend that the Board see the work that Mr. Ludwig did at Brooklands Park.

Ms. Mills spoke about the Clifford Theater show that will be performed. The production will be July 28 and 29, 2023.

Ms. Mills also spoke about upcoming events in the Village of Suffern for the Recreation Department. Valentine for Veterans was setup by the Gazebo area. Please drop off your cards for the veterans.

### **PUBLIC COMMENT** (limited to 4 minutes per speaker)

A motion to open the public comment was made by Trustee Alpert and seconded by Trustee Meegan-Corrigan, with all in favor.

• Ms. Patsy Wooters, 19 Mansfield Place advised the Board that she had the opportunity to go to the New York State Arborist Convention held at the Crowne Plaza. She will be coming back to talk about the economics of trees. She also mentioned that Mr. John Wickes was the President of the New York State Arborist and that he ran the convention.

Mayor Curley thanked her and told her to please keep the Village Board informed.

• Jim Giannettino asked if the Village will be maintaining the same threshold for the senior exemption as the Town of Ramapo.

Mr. Rice and Mayor Curley answered, "Yes." Mayor Curley added that the Village is giving the seniors the maximum.

• Mr. Giannettino asked, "What change in zone is Extell looking for?"

Mayor Curley said that Extell first came to the Village before he was Mayor asking for, he believes, 171 units. Then Extell went before the Planning Board with, he believes, 141 units. When Mayor Curley met with the developer, he told them that they must have two (2) parking spots for each unit. They came back with 212 parking spots for 106 units, but complained that they could not build a financially successful project with only 106 units. Mayor Curley said that they should go back to Avon and get a better price for the property. That is what Extell did.

Mr. Giannettino said that he used to say to applicants when he was on the Planning Board, that he was here to protect the Village not to make the applicant money.

The Mayor answered that he is here to protect the Village, but the applicants will not build unless they make money. So, if he can do both, that is what he will do. The applicants pay taxes; the Village of Suffern needs the tax money.

Mr. Giannettino asked to please put more information on the agendas.

Mayor Curley said that he would.

A motion to close the public comment was made by Trustee Meegan-Corrigan and seconded by Trustee Alpert, with all in favor.

#### **TRUSTEES**

• Trustee Alpert recommended discounted permit fees for people who are looking to go green (i.e., Energy Star windows, etc.).

Mayor Curley said that the attorney will research that idea and see if it is legal. He believed that it is a great idea for the Village residents who want to conserve energy.

• Trustee Hagen agreed with Former Mayor Giannettino regarding the agendas. He said we should share information.

Mayor Curley added that he always shares information with the public. He mentioned that every day he answers emails and questions.

#### **MAYOR**

Mayor Curley said that before the meeting, Trustee Hagen said that people have commented about the construction in Montebello. There is a 200 bed senior care facility with a memory car unit being constructed in the Village of Montebello (not the Village of Suffern) on Route 59 across from the Good Samaritan Hospital.

A project on Route 59 across from the Oakdale Manor Apartments and next to the Esther Gitlow building will be a 48-unit apartment building. We will increase our real property tax base and have more people walking downtown.

Another project located in the Village of Suffern is the Recon project on Washington Avenue. That will be a 60-unit apartment building.

Extell is looking to do a 106-unit apartment building. The Village of Suffern would have to do a zone change, but that would be after public hearings. The Mayor stated that he is changing the course in this Village by how much parking you have to have in order to build. He believes that was a mistake prior to his term of office. In the Mayor's opinion you cannot build without at least two parking spots per unit.

The Mayor believes that we are in need of more apartments and condos downtown. This increases our real property tax base, providing some relief to all property owners, and generates more people walking downtown and uplifting the Village.

Mayor Curley said that he has gone to illegal construction jobs with the Village Building Inspector and stopped the jobs. The Mayor said it was important to do. He feels he needs to know firsthand what is happening in the Village of Suffern.
