# **CALL TO ORDER**

Mayor Curley called the meeting to order at 7:41 P.M. and led everyone in the Pledge of Allegiance.

#### **UPCOMING MEETINGS**

#### **APPROVAL OF MINUTES**

**MOTION** To Approve November 20, 2023, Board of Trustees Meeting Minutes was moved by Trustee Meegan-Corrigan, seconded by Trustee Hogue, with all in favor.

#### **PUBLIC HEARINGS**

**MOTION** to Open Public Hearing to Consider the 2024 Community Development Block Grant (CDBG), was moved by Trustee Alpert, seconded by Trustee Meegan-Corrigan, with all in favor.

Mr. Fred Rella explained how the Community Development Block Grant ("CDBG") works. Federal (HUD) money goes through the Rockland County, who oversees it, and distributes it throughout the County. You must apply for it, and it is on a competitive basis.

Mr. Rella explained some of the previous grants that the Village of Suffern received. He also explained how the CDBG goes by income (low to moderate income in the Village. So, it has to be applied for and spent in a certain area of the village every year. The income is according to the US Census (every 10 years). Only one area in the Village that qualifies for the CDBG grant and that is in the West ward. Mr. Rella also explained the makeup of the CDBG Advisory Committee.

The two road paving projects in the West Ward of the Village of Suffern that the Advisory Committee agreed upon were 1) West Park Place from Ramapo Avenue west (approx. 350'), and

2) West Maple Avenue (350' from Meadow Avenue) estimated cost is \$150 thousand. We are going to ask for \$136 thousand, with a municipal contribution of \$14 thousand. They have not released the application yet. Mr. Rella said that he has a mandatory meeting this week with the County of Rockland regarding CDBG. Mr. Rella mentioned that it is federal money, and they want to see a roll call vote.

Trustee Alpert asked that if the project costs less than what the CDBG grant is does the Village get to keep the difference. Mr. Rella said no, the Village is not allowed to keep the difference. The Village gets a reimbursement for what they spend.... It is a reimbursement grant.

Jim Giannettino – How often do they determine if that area is still in the area that you get the grant? Mr. Giannettino stated that there are a lot of people moving in and moving out. There are a lot of renters that are renting to numerous people. Whose income are they looking at?

Mr. Rella – said that the Census is done every 10 years and they do update the numbers annually. Mr. Rella discussed a project that they had which they had to replace because when the Census data was released, the area was no longer a low to moderate income zone in Suffern.

# ACCEPTING THE VILLAGE OF SUFFERN CITIZEN ADVISORY COMMITTEE RECOMMENDATION FOR THE FY2024 CDBG GRANT APPLICATION TO BE SUBMITTED FOR THE WEST PARK PLACE AND MEADOW AVENUE PAVING PROJECT

**RESOLVED,** the Village Board of Trustees accept the recommendation of the Village of Suffern Citizen Advisory Committee to seek Community Development Block Grant (CDBG) funding for the West Park Place and Meadow Avenue Paving Project and authorizes the Mayor or his authorized designee to sign and submit the FY2024 CDBG application for the said project; and

**BE IT FURTHER RESOLVED,** The CDBG application will state that the West Park Place and Meadow Avenue Paving Project cost will be \$150,000. Of this total, \$136,000 will be contributed from the Community Development Block Grant and \$14,000 (approximately 10% of the grant) will be contributed from the Village of Suffern (if a lesser amount of CDBG funds are awarded to the Village of Suffern, the village contribution shall remain constant at no more than 10% of any such CDBG award unless the village deems otherwise, i.e. a \$100,000 award will equate to a \$10,000 Village of Suffern contribution); and

**BE IT FURTHER RESOLVED**, additionally, the Village of Suffern contribution can be the cost of a "project coordinator" and/or Village labor (soft) expenses for the development, implementation and oversight of the West Park Place and Meadow Avenue Paving Project.

WHEREAS in addition to her normal duties as Village Clerk, the Village Clerk is undertaking several major projects, including the imaging of all birth and death certificates from 1896 to the present imaged to electronic format and microfilm; the development and implementation of employee manuals and training in various human resource issues as required by federal and state law, and the implementation and coordination between departments of the policies and procedures to effectively administer the Village's rental registration law; and

**WHEREAS** the aforementioned projects would otherwise require the engagement of several professionals at significant additional cost to the Village.

**NOW, THEREFORE, BE IT RESOLVED,** that the Village Board of Trustees hereby approves an increase in the compensation to be paid to the Village Clerk of \$26,800 for the period beginning December 5, 2023, and ending May 31, 2024; and

**BE IT FURTHER RESOLVED** that the Village Treasurer is authorized to transfer \$28,800 from the Contingent Account to Village Clerk Personal Services (\$26,800) and Employee Benefits – FICA (\$2,000), to provide for the additional compensation plus the employer's share of FICA.
