APPROVAL OF MINUTES

MOTION To Approve August 4, 2025, Board of Trustees Meeting Minutes was moved by Trustee Osborn, seconded by Trustee Meegan-Corrigan with all in favor.

PUBLIC HEARING:

MOTION: To open the Public Hearing to consider a Local Law Amending Section 205-3(6) of the Code the Village of Suffern regarding Vehicle Parking in the Village of Suffern, was moved by Trustee Alpert and seconded by Trustee Hogue with all in favor.

This has to do with you are allowed one commercial vehicle for every home, if it is past the line of your house. We are finding people are trying to hide this by using car covers. We are adding to the law that you must keep your plate where it is visible to a Code Enforcer or someone else that might be going by. Also, that the car cover must be in good repair and approved by the Building Inspector or Code Enforcer.

BE IT ENACTED by the Board of Trustees of the Village of Suffern as follows: **WHEREAS**, in order to ensure that the parking of vehicles is in compliance with the provisions of the Code of the Village of Suffern, the Board of Trustees deems it to be advisable that the license plate of all parked vehicles be visible; and

WHEREAS, the existing provisions of the Village Code have been reviewed to ascertain whether they provide adequate requirements to ensure that license plates are visible; and

WHEREAS, the Board of Trustees deems it advisable to adopt an amendment to Chapter 205 to achieve the aforementioned goals; and

WHEREAS, a notice of the public hearing on said local to be held on September 8, 2025 was timely published in the Journal News on August 20, 2025 and posted in six public places; and

WHEREAS, the action is a Type II action pursuant to the State Environmental Quality Review Act; and

WHEREAS, a public hearing was held on September 8, 2025 at which time the public had an opportunity to comment on the proposed local law and the hearing was closed.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Village of Suffern that the Board of Trustees hereby declares itself to be lead agency and determines that that the adoption of the proposed local law is a Type II action pursuant to the State Environmental Quality Review Act; and

BE IT FURTHER RESOLVED, that the Board of Trustees finds that all procedural requirements for the adoption of said local law have been satisfied; and

BE IT FURTHER RESOLVED that it is in the overall public interest of the Village of Suffern to adopt said local law; and

BE IT FURTHER RESOLVED that Local Law No. 4 of 2025, "A Local Law Amending § 205-3(A)(6) of the Code of the Village of Suffern regarding vehicle parking in the Village of Suffern" is hereby adopted.

LOCAL LAW NO. 4 OF 2025

A LOCAL LAW AMENDING § 205-3(A)(6) OF THE CODE OF THE VILLAGE OF SUFFERN REGARDING VEHICLE PARKING IN THE VILLAGE OF SUFFERN

BE IT ENACTED by the Board of Trustees of the Village of Suffern as follows:

Section 1. Section 205-3(A)(6) of the Code of the Village of Suffern is hereby amended to provide as follows:

It shall be unlawful to park or store or permit to be parked or stored in any yard or open area of a premises any motor vehicle that is abandoned, wrecked, dismantled, junked, substantially damaged or unregistered or which is not intended to be used or in no condition for legal use upon the public highway. No vehicle parked or stored out of doors on any property shall be covered with any tarp, material or matter other than a car cover for which the vehicle license plate is exposed and clearly visible.

Section 2. This local law shall take effect immediately upon filing with the Secretary of State.

MOTION – To open the Public Hearing for amending Local Law Section 245-67, the Code of Village of Suffern establishing a handicap parking space on Suffern Place, was moved by Trustee Meegan-Corrigan and seconded by Trustee Alpert with all in favor.

We have had requests for some more handicapped parking spaces and are looking at more locations.

WHEREAS, the location and necessity of a handicapped parking space at the requested location has been investigated and found to be appropriate; and

WHEREAS, the Board of Trustees deems it advisable to create a handicapped parking space at that location; and

WHEREAS, a notice of the public hearing on said local to be held on September 8, 2025 was timely published in the Journal News on August 20, 2025 and posted in six public places; and

WHEREAS, the action is a Type II action pursuant to the State Environmental Quality Review Act; and

WHEREAS, a public hearing was held on September 8, 2025 at which time the public had an opportunity to comment on the proposed local law and the hearing was closed.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Village of Suffern that the Board of Trustees hereby declares itself to be lead agency and determines that that the adoption of the proposed local law is a Type II action pursuant to the State Environmental Quality Review Act; and

BE IT FURTHER RESOLVED, that the Board of Trustees finds that all procedural requirements for the adoption of said local law have been satisfied; and

BE IT FURTHER RESOLVED that it is in the overall public interest of the Village of Suffern to adopt said local law; and

BE IT FURTHER RESOLVED that Local Law No 5 of 2025, "A Local Law Amending establishing a handicapped parking space on the east side of Suffern Place, 154 feet from its intersection with Lafayette Avenue in the Village of Suffern" is hereby adopted.

FEET FROM ITS INTERSECTION WITH LAFAYETTE AVENUE IN
THE VILLAGE OF SUFFERN

BE IT ENACTED by the Board of Trustees of the Village of Suffern as follows:

Section 1. Section 254-67 of the Code of the Village of Suffern, Schedule XVII: Handicapped Parking Spaces, is hereby amended to add after: [Name of Street] Parkside Drive [Side] North [Location] Opposite Salem Court, the following:

[Name of Street] [Side] [Location]

Suffern Place East 154 North from the Intersection with Lafayette Avenue

Section 2. This local law shall take effect immediately upon filing with the Secretary of State.

Chief Loughlin

Presented the Police Department statistics for the month of August 2025.

"The Police Department applies for an annual grant through the Governor's Traffic Safety Committee, which supplies additional funding to local municipalities to participate in the statewide Police Traffic Service Programs. The goal of this program is to increase seatbelt usage and reduce dangerous driving behaviors in an effort to reduce serious injuries and fatalities from traffic crashes. This year, we've been awarded \$11,000 in funding to participate in the program, which covers the cost of additional officers on the street for the purpose of traffic enforcement."

RESOLUTION NO. 110 OF 2025

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT WITH H2O INNOVATION OPERATION & MAINTENANCE, LLC WITH RESPECT TO WATER OPERATIONS AT THE VILLAGE WATER TREATMENT FACILITY

BE IT ENACTED by the Board of Trustees of the Village of Suffern as follows: **WHEREAS**, the Village of Suffern owns and operates a publicly owned water system and water facility; and

WHEREAS, State regulations require that a NYSDOH Grade IB Water Operator be present at the facility; and

WHEREAS, the Village requires assistance in the training of a Grade IB Water Operator and coverage at certain times; and

WHEREAS, H2O Innovation Operation & Maintenance, LLC has submitted a proposal to provide such professional services; and

WHEREAS, the proposal offers to provide the following services: 1) Hire, train, and employ one (1) full-time NYSDOH Grade IB Water Operator to staff and operate the facility; Operator shall also provide facility coverage every third weekend at additional hourly cost as

noted in section of the agreement; 2) Operator shall assist the Village's staff with sewer & water pump station checks, supervision of water main breaks, delegation of alarm and callout schedules, and general work direction of the Village staff; 3) Provide sufficient staff that will meet certification requirements of the State of New York and provide Labor and Benefits Costs to all employees assigned on a full-time basis to the Project; 4) Prepare all Federal and State regulatory water permit reports and submit these to the Village and the appropriate State and Federal agencies; 5) Provide assistance to the Village's engineering staff or consultants in review of any proposed project rehabilitation plans for the utilities; 6) Document all repair parts and expenses incurred on behalf of the Village. The Operator shall update the Village monthly on the cost-to-date of repair parts and supplies for budgetary purposes; 7) Perform other professional management services as directed by the Village as negotiated on a case-by-case basis; 8) Pay for and/or cover all of the Direct Costs as identified in part 1 of Appendix B for water and/or wastewater treatment plants and facilities; 9) Provide process sampling and laboratory analysis for the water facility at a frequency sufficient to meet permit requirements.

WHEREAS, such work constitutes professional services not subject to competitive bidding; and

WHEREAS, the Board of Trustees is desirous of entering into a contract with H2O Innovation Operation & Maintenance, LLC for the aforementioned professional services.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Village of Suffern that the Mayor is hereby authorized to execute a contract with H2O Innovation Operation & Maintenance, LLC, in accordance with the agreement dated September 1, 2025, subject to approval by the Mayor and Village Attorney as to form and substance. A motion to approve the foregoing resolution was made by Trustee Osborn and seconded by Trustee Alpert, with all in favor.

WHEREAS, the Village's General Fund available fund balance will remain above 35% of revenues if \$267,010 or less of General Fund available (unassigned) fund balance is appropriated and transferred to the Capital Projects Fund to finance the Village Right of Way Improvements.

BE IT ENACTED by the Board of Trustees of the Village of Suffern as follows: **WHEREAS**, on April 3, 2023, the Board of Trustees adopted certain revisions to the Standard Schedule of fees; and

WHEREAS, having worked with the revisions for more than two years, a revision to one of the provisions is appropriate.

Section 1. The following portions of the Standard Schedule of Fees are amended to provide as follows:

Building Inspection Fee for construction without

a building permit Regular building permit fee plus the following:

Permit for roof replacement: \$50.00

Cost of building permit (other than roof replacement):

up to \$50,000: \$1,000.00

\$50,001 to \$100,000: \$2,000 \$100,001 to \$200,000: \$3,000

Over \$200,001: \$5,000.00.

Section 2. This resolution shall take effect immediately.

If someone doesn't get a permit for their roof, we have set up a fee schedule, which is something that we did within the last year or so. We are realizing the roof is an issue where your actual taxes don't go up, like when you do a major renovation. We have a lot of residents that don't understand about roofs, they think it is a common thing to repair or fix their roof. We You will still need to get a permit for work on your roof, but the fee, if we catch you after the fact, is going to be \$50.

Curley: They don't have any arrangements as of yet, they are going to plan something down the line. He had a brother that was an attorney, the head DA in Rockland County as well as a judge.

I think he had another brother that was the playwright of the play Annie that was on Broadway. It is always a loss to a community, people with that kind of history and love for our community.
